CORN PRODUCTS INTERNATIONAL INCREASES QUARTERLY DIVIDEND TO \$0.20 PER SHARE

WESTCHESTER, Ill., December 14, 2011 – The Board of Directors of Corn Products International, Inc. (NYSE: CPO) today declared a quarterly dividend of \$0.20 per share on the Company's common stock. This represents an increase of \$0.04 per share, or 25% compared to the previous quarterly dividend of \$0.16. This also marks the second time the Company has increased its dividend in the past year.
